Dear Rex,

This letter is to notify you of the resolution of a report filed by the MIT Police regarding the night of September 13th, 2019. According to the report, the officer noticed a female vomiting into a trash barrel who may have been drunk that had no proof of ID near the front door. Based on this information, Delta Tau Delta may have violated the following policy from the IFC Risk Management Policy.

### IFC Risk Management Policy

#### **III.** Control of Alcohol

D. Alcohol should not be served to any individual who does not have a proper wristband, whose hand has been marked as an underage guest, or who is not of the age of 21. In addition, no alcohol should be served to an individual who is visibly intoxicated. Party monitors shall monitor the event for guests distributing alcohol or for underage guests possessing alcohol and will deal with such guests accordingly.

After reviewing your response, I have decided to resolve this case administratively. Based on the totality of the information available to me, I have found Delta Tau Delta not response for violating the Control of Alcohol Policy due the fact the guest in question did not consume alcohol at Delta Tau Delta's event. The brothers did a great job of noticing her intoxication and offering water as well as offering to call a transport.
