### **Report from the President:**

#### Summer Housing Policy

- An AILG committee has been formed to look into a new summer housing policy for the upcoming summer. For those who do not know what the AILG is, it is in many ways an alumni version of the IFC and is made up of alumni representatives from the different Greek chapters.
- Marlena Martinez (Assistant Director of FSILG Office) chairs the committee.
- The committee came about because of facility and behavior issues from boarders, and the city of Cambridge wants tougher restrictions placed upon future boarders.
- In response, MIT is forming a new policy.
- Right now, it seems the committee will recommend renting to greater Boston area college students exclusively, with the notable exception of allowing members of the same Greek affiliation to live in the house.
- The next meeting of the committee will be at end of February. If you are interested in joining the committee, email Marlena Martinez.

#### RA Policy Committee

- City of Cambridge again wants MIT to revamp their policies.

- Retreat with AILG—hope to work closer with AILG; no miscommunications

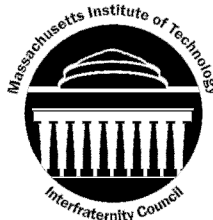
### **Vice-President**

## **JudComm Chair**

### Judicial Process

- We wish to increase transparency, by making available reports about what is currently happening in the judicial system (who has sanctions, etc.).
- LCA has hearing—no alcohol social and no own alcohol
- ATO still under "1 and done" policy.
- Policy change: A minimum sanctions list will be implemented. It is a list of RM policies that gives suggestions for sanctions for various infractions
- Minimums hope to ensure objectivity and consistent sanctions.
