#### CPW

- IFC hosting three events + Carnival
  - Two information sessions (pre-frosh/parents) on Friday night
  - IFC meet and great from 11am-12am on Saturday
  - Need high fraternity attendance
- Alcohol Inspections
  - Will be held from 10am-midnight
    - Most likely not during school hours
  - Inspectors being chosen currently
  - No warning when they are coming, random
  - IFC Exec members will be coming around as well
  - 4/5pm Saturday is the end
  - Need someone ready to let inspector inside
- Unanimous Agreement X
  - Sorority women are not allowed to be rush girls
  - Reminder for CPW, but not specific strict rules for the weekend
  - Not allowed to advertise for fraternities (wear letters, etc.)
  - \*\* Applies to sorority women from other chapters (national Panhell bylaw) \*\*
- Risks/Rules
  - Pre-gaming issues
    - Others from around Cambridge and Boston
    - Look out for it
    - Same rules apply to a sick person
    - Will increase likelihood of shutting down a party quickly
  - Events around the same time
    - Watch out for excessive lines around fraternities
    - Keep them under control
- Carnival Saturday 12am-3pm (setup at 10am)
  - Need volunteers – good for networking
- Movie on the lawn event (Panhell and IFC)
